Three notices of decision were issued for in progress applications which involved delineations and TEP input. One violation was reported and issued, subsequently the landowner and Hubbard SWCD have discussed correction plans to take place in spring 2020.</p> <p>Some one on one training has been provided to Crystal both regarding WCA background and policies as well as field work.</p>
