

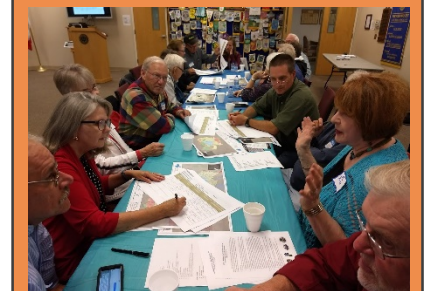

## Tidbits

According to Peter Jacobson, Minnesota DNR, “Tullibeas are a great ‘canary in a mineshaft’ species” (Star Tribune, Feb 2, 2015). Tullibeas thrive in cold, deep lakes with plenty of oxygen. If you have tullibeas, you’ve got healthy water. The Leech Lake River watershed has 12 lakes that support tullibee; 2 lakes are in Hubbard County (Benedict, Kabekona) and 10 lakes are in Cass County (Cooper, Girl, Howard, Little Woman, Long SW Bay, Long Main Basin, Man, May, Portage, Ten Mile).
