Actual Results	<p>2020: In house nitrate clinics were restricted for a portion of 2020 due to Covid19. Hubbard SWCD was able to conduct 5 of 12 in-house clinics and we offered drop off testing as an alternative with a drop off event taking place once at Ruby's Pantry in Laporte.</p> <p>2021: Held monthly in house nitrate drop off clinics plus 3 community remote drop off clinics and 4 event clinics. Conducted 265 unique tests and advised 42 landowners with elevated nitrate levels on water filtration options.</p>

Description	Designated to support the effort to continue recording obwell data 4 times a year. The data is important to understanding water quality in Hubbard County, but DNR support for the effort does not cover SWCD costs for time in the field and reporting.
